





**Release of Liability  
Acceptance Of Risk**

Presentation of a signed entry form shall be deemed acceptance of the rules of and all other rules pertaining to this show. In the event of failure to sign an entry form, then first entry of horse or an exhibitor into the show ring shall be deemed to be acceptance of the show rules. Horses are entered at your own risk & are subject to breed and show rules, under which these classes will be conducted. In case of death, accident, injury or theft, to the exhibitor, their family, horses or property, no claims will be honored against Southwest Show Management, Texas Paint Horse Club, (including any affiliate or officer of Texas Paint Horse Club), City of Fort Worth, and/or all of those associated with any or all affiliated to this show of the above mentioned organizations

General Facility Guidelines – City of Fort Worth may or may not enforce City compliant COVID restrictions throughout competition facilities.

I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any equestrian event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of Will Rogers Equestrian Center, or Event organizers and competition management, and/or Texas Paint Horse Club; and other undefined, not readily foreseeable and presently unknown risks and dangers. With this in mind, I accept full responsibility for my own safety and EXPRESSLY ASSUME ALL RISKS OF HARM, whether foreseen or unforeseen while participating in equestrian activities at the Will Rogers Equestrian Center. I am physically fit and know of no medical or health reason why I should not participate in this activity. I hereby RELEASE and agree to DEFEND, INDEMNIFY AND HOLD HARMLESS Southwest Show Management & Texas Paint Horse Club, employees, agents, instructors, equipment manufacturers, lessors, and insurers (hereinafter collectively referred to as “Parties Released”), from and against any liability, demand, claim, or right of action for any damage or injury, including paralysis or death, to any person or property, even if such damage or personal injury results from the NEGLIGENCE of SSM, WRMC or TPHC & other Parties Released. I further COVENANT NOT TO SUE or make any demand or claim against SSM/TPHC or other Parties Released, for or by reason of any such damage or personal injury from my participation in equestrian activities at WRMC. I will pay all fees, damages, and costs, including attorney fees that WRMC, TPHC or Southwest Show Management (Southwest Specialties LLC) or other Parties Released may incur in the enforcement of this agreement. A signed liability waiver is a condition to your participation in any event. Failure to sign will lead to your disqualification and removal from property. I have carefully read this document and fully understand its contents, which I adopt as a completely integrated and exclusive statement of the entire terms of agreement. PUBLISHING OF PICTURES, VIDEOS, & COMPETITION SHOTS ON PROPERTY – Southwest Specialties LLC may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage, or benefit of the competition, sport, or facility. I HAVE REVIEWED AND ACKNOWLEDGE & WILL ADHERE TO ALL AFOREMENTIONED REQUIREMENTS.
